Having regard to the submissions made by the learned counsel on either side and taking into consideration the limited prayer sought for by the petitioners, without expressing any opinion with regard to the merits of the case, I direct the second respondent to receive the respective applications of the petitioners dated 05.01.2016 in Form CCPA and the prescribed fee for the grant of Autorickshaw permit and consider the same on merits and in accordance with law, within a period of six weeks from the date of receipt of a copy of this order.

4. With this observation, all the writ petitions are disposed of. No costs.
