Prayer : Petition filed under Article 226 of the Constitution of India praying for issuance of a writ of habeas corpus calling for the records in connection with the order of Detention passed by the 2nd respondent dated 22.07.2015 in BCDFGISSSV No.584/2015 against the son of the petitioner, Detenu Ajithkumar @ Vellai Ajith M/A 23, S/o Ramachandran, who is confined at Central Prison, Puzhal, Chennai and to set aside the same and consequently direct the respondents to produce the detenu before this Court and set him at liberty.

ORDER

The petitioner, who is the mother of the detenu Ajithkumar @ Vellai Ajith, son of Ramachandran, aged about 23 years, has come forward with this petition challenging the detention order passed by the second respondent dated 22.07.2015 against her son branding him as a "Goonda" under the Tamil Nadu Prevention of Dangerous Activities of Bootleggers, Drug Offenders, Forest Offenders, Goondas, Immoral Traffic Offenders, Sand Offenders, Slum Grabbers and Video Pirates Act, 1982 [Tamil Nadu Act 14 of 1982].

2.The learned Additional Public Prosecutor would submit that the order of detention passed by the second respondent as against the husband of the petitioner dated 22.07.2015 has been revoked by the Government in G.O. [Rt] No.5587, Home, Prohibition & Excise [XIII] Department dated 01.09.2015 and he has also produced a copy of the said order.

3. Recording the submission of the learned Additional Public Prosecutor, this petition is closed as the same has become infructuous.
