Prayer : Petition filed under Article 226 of the Constitution of India praying for issuance of a writ of habeas corpus calling for the entire records relating to Thiru.Babu @ Hari Babu, the detenu under Act 14 of 1982 vide detention order No.535/2015 dated 13.07.2015 on the file of the 2nd respondent herein and quash the same as illegal and consequently direct the respondents to produce the detenu Thiru. ORDER

The petitioner, who is the mother of the detenu Babu @ Hari Babu, son of Ramu @ Selvaraj, aged 24 years, has come forward with this petition challenging the detention order passed by the second respondent dated 13.07.2015 against her son branding him as a "Goonda" under the Tamil Nadu Prevention of Dangerous Activities of Bootleggers, Drug Offenders, Forest Offenders,

Goondas, Immoral Traffic Offenders, Sand Offenders, Slum Grabbers and Video Pirates Act, 1982 [Tamil Nadu Act 14 of 1982].

2.The learned Additional Public Prosecutor would submit that the order of detention passed by the second respondent as against the son of the petitioner dated 13.07.2015 has been revoked by the Government in G.O.[Rt] No.5374, Home, Prohibition and Excise (X) Department dated 19.08.2015 and he has also produced a copy of the said order.

3. Recording the submission of the learned Additional Public Prosecutor, this petition is closed as the same has become infructuous.
