Prayer : Criminal Original Petition filed under Section 482 of the Code of Criminal Procedure, praying to [a] direct the first respondent to take steps to get a case registered on the basis of the petitioner's complaint dated 20.05.2013 and entrust the investigation of the case by nominating an officer not below the rank of the Deputy Superintendent of Police as contemplated under Rule 7 of the Scheduled Castes and Scheduled Tribes [Prevention of Atrocities] Act, 1989 who shall complete the investigation within 30 days as stipulated in Rule 7 thereof and file a final report within a time frame [b] direct the first respondent to take steps to get a case registered against the second respondent herein and the third respondent-Police for the offence under Section 4 of the Scheduled Castes and Scheduled Tribes [Prevention of Atrocities] Act, 1989 and nominate an officer above the rank of the second respondent herein as contemplated under Rule 7 of the Scheduled Castes and Scheduled Tribes [Prevention of Atrocities] Act, 1989, who shall complete the investigation within 30 days as stipulated in Rule 7 thereof and file a final report within the time frame.

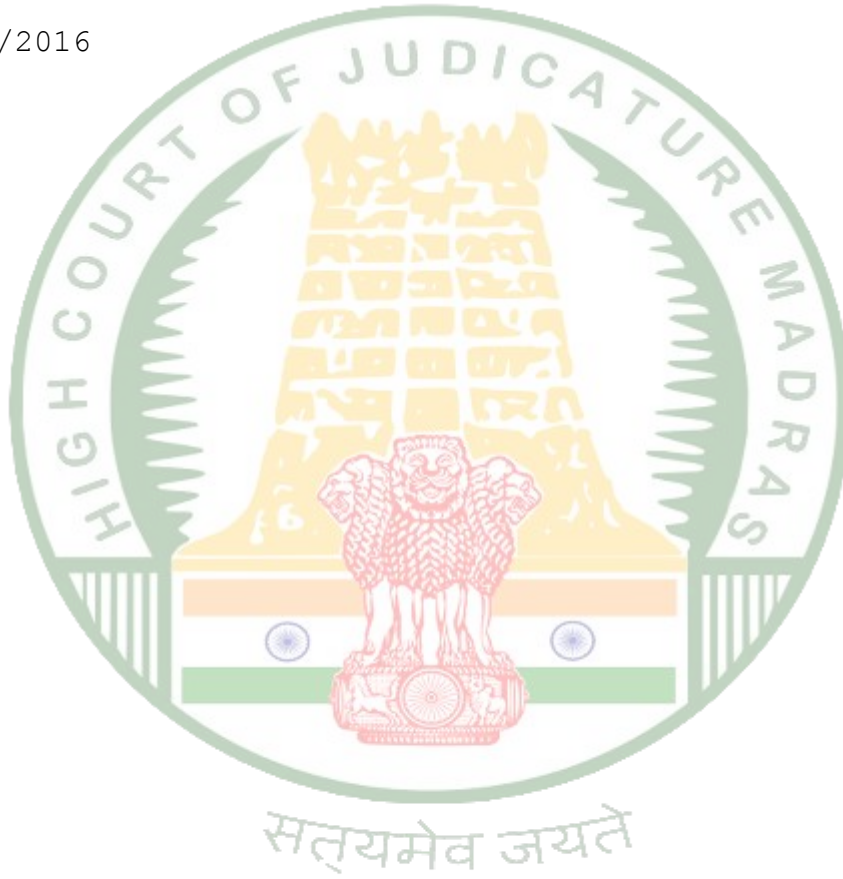
