Petition filed under Article 226 of the Constitution of India praying for a writ of Habeas Corpus calling for the records relating to the impugned detention order made in PBMMSECA No.3/2015 dated 19.08.2015 on the file of the 2nd respondent herein and quash the same as illegal and direct the respondent to produce the detenu Sathiya aged about 32 years, residing at No.95/10, KCB Road, Indira Gandhi Nagar, Thiruvotriyur, Chennai, now confined at Special Prison for Women, Puzhal, Chennai-66 before this Court and set her at liberty.

ORDER

The petitioner who is the husband of the detenu Sathiya, aged about 32 years, has come forward with this petition challenging the detention order passed by the 2nd respondent dated 19.08.2015, branding his wife as a "Black Marketer" under the provisions of the Tamil Nadu Prevention of Black Marketing and Maintenance of Supplies of Essential Commodities Act, 1980 [Central Act 7 of 1980].

2 Learned counsel for the petitioner would submit that the detention period has already been over and that the petition has become infructuous. He has also made an endorsement in the petition to that effect.

3 In view of the submission and endorsement made by the learned counsel for the petitioner, this Habeas Corpus Petition is dismissed as infructuous.
