In any case, the larger issue of selling of unapproved housing sites has received our attention in two writ petitions being W.P.No.3073 of 2013, decided on 15.06.2016 and W.P.No.12847 of 2013, decided on 27.06.2016, where directions have been issued to the State Government. In view thereof, no further directions are required in this writ petition.
