ORDER

The petitioner, who is the wife of the detenu Sukku @ Suresh, son of Rajendran, aged about 31 years, has come forward with this petition challenging the detention order passed by the second respondent dated 12.09.2015 against her husband branding him as a "Goonda" under the Tamil Nadu Prevention of Dangerous Activities of Bootleggers, Drug Offenders, Forest Offenders,

Goondas, Immoral Traffic Offenders, Sand Offenders, Slum Grabbers and Video Pirates Act, 1982 [Tamil Nadu Act 14 of 1982].

2.The learned Additional Public Prosecutor would submit that the order of detention passed by the second respondent as against the husband of the petitioner dated 12.09.2015 has been revoked by the Government in G.O. [Rt] No.6808, Home, Prohibition & Excise [XIV] Department, dated 29.10.2015, and he has also produced a copy of the said order.

3. Recording the submission of the learned Additional Public Prosecutor, this petition is closed, as the same has become infructuous.
