Prayer : Petition filed under Article 226 of the Constitution of India praying for the issuance of a Writ of Habeas Corpus calling for the entire records leading to the detention of the petitioner's husband Thamizharasan @Thambidurai s/o.Durai M/A 30 years under Act 14 of 1982 as a Goonda vide detention order dated 31.8.2015 on the file of the 2nd respondent herein made in BDFGISSV/841/2015, quash the same, and consequently direct the respondents herein to produce the body and person of the said detenu before this Court and thereafter set him at liberty from the Central Prison, Puzhal, chennai.

2.The learned Additional Public Prosecutor would submit that the order of detention passed by the 2nd respondent as against the husband of the petitioner dated 31.8.2015, has been revoked by the Government in G.O.Rt.No.6537, dated 16.10.2015, and he has also produced a copy of the said order.

3. Recording the submission of the learned Additional Public Prosecutor, this petition is closed as the same has become infructuous.
