Considering the pendency of the complaint made by the petitioner dated 30.11.2015 before the respondent No. 1 who is the Inspector of Panchayats, the said authority is directed to consider and pass appropriate orders on the pending complaint of the petitioner dated 30.11.2015, within a period of eight weeks from the date of receipt of copy of this order, after affording an opportunity of hearing to the petitioner as well as the respondent No. 4.

4. With the above direction the present writ petition is disposed of. No costs.
