The push cart vendor sought to have a permanent space as per the finding in the impugned order. In a separate proceedings in W.P.No.33821 of 2014 relating to N.S.C. Bose Road, the Vending Committee has already enumerated the eligible hawkers.

2. In view of the aforesaid, no separate petition filed by the petitioner is maintainable and it is for the petitioner to approach the Vending Committee.

3. The writ petition is dismissed in terms aforesaid. No costs. Consequently, M.P.No.1 of 2011 is closed.
