Prayer : Petition filed under Article 226 of the Constitution of India praying for issuance of a writ of habeas corpus calling for the entire records of the detaining authority, the detaining authority/the District Collector and District Magistrate, Coimbatore District, the 2nd respondent herein made in Ref Cr.M.P.No.61/G/2015/E1, dated 28.11.2015 detaining the detenu Kannan @ Nivethakannan son of Ananthakumar aged 22 years under Tamil Nadu Act 14 of 1982 as a Goonda and was confined in Central Prison, Coimbatore and set aside the same and consequently direct to produce the detenu at liberty forthwith.

2. The learned Additional Public Prosecutor had submitted that the order of detention passed by the 2nd respondent as against the son of the petitioner, dated 28.11.2015, has been revoked by the Government in G.O.Rt.No.429, dated 1.2.2016, and he has also produced a copy of the said order.

3. Recording the submission of the learned Additional Public Prosecutor, this petition is closed as the same has become infructuous.
