4.With this observation, the Writ Petitions are disposed of. No costs.

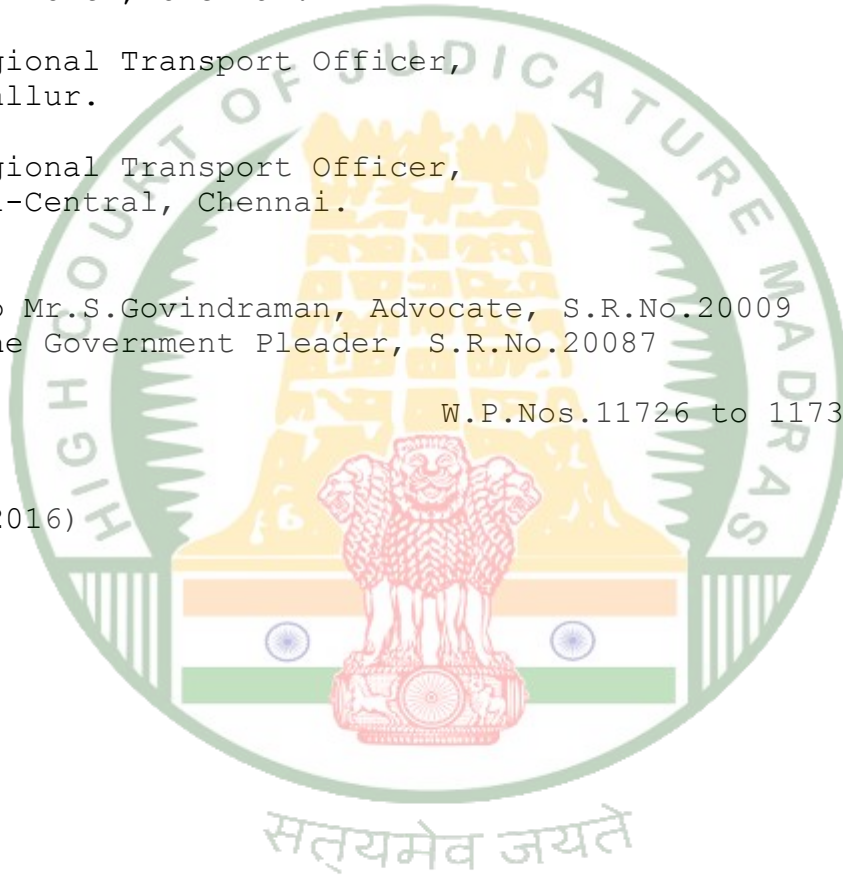
