Heard.

2 The learned counsel appearing on behalf of the petitioner had submitted that the second respondent has issued a communication, dated 1.11.2013, stating that the petitioner may not be entitled to, for the allotment of the house, under the Chief Minister's Environment Green House with Solar Energy Scheme, as prayed for by the him. However, his request may be

considered, under the Indira Memorial Housing Scheme.

3 In view of the said communication issued by the second respondent, this Court finds it appropriate to permit the petitioner to make an application for the allotment of the house, as prayed for by him, under the Indira Memorial Housing Scheme. The petitioner may make such an application, if so advised, to the first respondent, within a period of fifteen days from the date of receipt of a copy of this order. On receipt of such application, the first respondent shall consider the same and pass appropriate orders thereon, within a period of six weeks, thereafter. The writ petition is disposed of, accordingly. No costs.
