The petitioner is given a further period of two weeks from the date of receipt of copy of this order, to file such application before the concerned authority. On receipt of the same, the said authority will have to consider the same and decide it on merits.

4. With the above direction the present writ petition is disposed of. Consequently, connected miscellaneous petitions are closed. No costs.
