2 In view of the above submission and endorsement made by the learned counsel for the petitioner, this writ petition is dismissed as withdrawn, with liberty to make a representation to the sixth respondent as aforestated, if so advised. If a representation is made within a period of one week to the sixth respondent bringing into his notice the fact of the illegal construction in any of the area or building, the sixth respondent is directed to examine the said representation and take consequential action in accordance with law on its own merits, at the earliest.
