COMMON ORDER

While Crl.O.P No.11883 of 2016 has been filed seeking to direct the second respondent police to register the complaint dated 09.04.2016 and investigate the same, Crl.O.P. No.11884 of 2016 has been filed to direct the second respondent to provide

police protection to the petitioner to Shop No.E-22, Thanthai Periyar Vegetable Market, Koyambedu Commercial Complex, Chennai 600 092.

2. Heard the learned counsel for the petitioner and the learned Additional Public Prosecutor appearing for the State.

3. On a reading of the complaint dated 09.04.2016, it is seen that the petitioner is an allottee of a CMDA shop in Koyambedu and that one hawker by name Kumar is also keeping and selling certain vegetables right near the petitioner's shop, thereby, hampering the petitioner's business.

4. In a case of this nature, no positive direction can be issued to the respondent police to register an FIR or give police protection as prayed for.

In the result, these petitions are closed with liberty to the petitioner to work out his remedy in the manner known to law.
