The petitioner is directed to file an affidavit explaining as to how the said V.Krishna, S/o.(late) Veerappa is related to the petitioner and the State Level Scrutiny Committee is directed to get a report from the concerned Tahsildar/Revenue Divisional Officer regarding the proof of relationship and consider the claim of the petitioner afresh and pass orders within a period of two months from the date of submission/affidavit by the petitioner."
