The learned Government Advocate submitted that the order of this Court which is the subject matter of contempt, has been complied with in the form of G.O.[D] No.127, Environment and Forests [FR.1] Department dated 04.07.2016. The learned Government Advocate also produced

3 The learned counsel for the petitioner would submit that it is only a partial compliance and liberty may be granted to the petitioner to challenge the said portion of the order which is acting adverse to the interest of the petitioner.
