COMMON ORDER

3. In view of the above, Registry is directed to list the vacate stay petitions filed in W.P.Nos.8302, and 8861 to 8864 of 2016, at the earliest before appropriate Bench, during the course of next week.

4. With the above observation, the Contempt Petitions are closed, as stated above.
