Today, when the matter was called, Mr.R.Thiagarajan, learned counsel appearing for the alleged contemnor has handed over two cheques bearing Nos.090355, dated 15/09/2016 for a sum of Rs.16,20,000/- in the name of Sandip Batra and 090356 dated 15/09/2016 for a sum of Rs.4,30,484/- to the learned counsel for the petitioner under acknowledgment.

5. In view of the above, this contempt petition is closed with liberty to the contemnor to move the concerned

Court for modification of the order in O.A.No.453 of 2014 dated 26/06/2014, if so advised.
