On receipt of such complaint, the Deputy Commissioner of police, Central Crime Branch, Coimbatore is directed to assign the same to competent Inspector of Police for enquiry and investigation and action be taken thereon in accordance with law, if it discloses the commission of a cognizable offence or drop action otherwise.
