I respectfully submit that the petitioner herein has suppressed the material fact in the writ petition filed by him in W.P.No.33955 of 2015 that the tenants have filed a RCOP Petitions in RCOP.No.26 of 2012, 27 of 2012, 28 of 2012, 30 of 2012 and 31 of 2012 on the file of Rent Controller, Ambattur, against the petitioner herein and the vendor of the petitioner's property. Further the said Rent Control Original Petitions are pending before the Rent Controller, Ambattur, and has obtained order dated 27.10.2015."

3. In view of the above, it is unnecessary to pursue the contempt at this stage. Hence, the Contempt Petition is closed.
