Prayer:- Contempt Petition is filed under Section 11 of the Contempt of Courts Act, to punish the respondent for the willful disobedience of the orders passed by this Court in CrI.O.P.No.6836 of 2016 dated 07.04.2016.

ORDER

Heard the learned counsel appearing for the petitioner and Mr.Mohamed Riyaz, learned Government Advocate (crl. Side) appearing for the respondent.

2.The petitioner herein has filed CrI.O.P.No.6836 of 2016 under Section 482 Cr.P.C. seeking a direction to the respondent police to register a case on the basis of the complaint lodged by him dated 18.03.2016. This Court, by

order dated 07.04.2016, directed the first respondent therein to expedite the enquiry and follow the dictum laid down in ***Lalitha Kumari v. Government of U.P. and others [2013 (4) Crimes 243 (SC)]*** and register a case, if any cognizable offence is made out.

3. According to the petitioner, the respondent/contemnor, who is the second respondent therein, has neither conducted any enquiry nor registered a case and that he has willfully disobeyed the order passed by this Court. Hence, the petitioner, has filed the present contempt petition.

4. Today, the respondent/contemnor is present and submitted that in obedience of the order passed by this Court dated 07.04.2016, a case in Crime No.307 of 2016 has been registered for the offences under Section 420 PC on 22.07.2016. He also tendered his unconditional apology for the delay in implementing the order of this Court dated 07.04.2016.

5.In pursuant to the order passed by this Court dated 07.04.2016, since the respondent has registered a case in Crime No.307 of 2016 on 22.07.2016, this Contempt Petition is closed.
