Writ petition has been filed under Article 226 of the Constitution of India, praying for a Writ of mandamus directing the respondent to grant permission and protection to conduct cultural program (Dance & Music Program) in the "Jothi Talkies West Pallakuchi Street Sri Kaliyamman Kovil" situated at I.E.Jothi Talkies, West Pallakuchi Street, Ammapet, Salem-636 003 scheduled to be held on 29.05.2016 from 6.00pm to 11.00pm.

ORDER

By consent, the main writ petition itself is taken up for final disposal.

2. Seeking permission to conduct cultural programme on 29.5.2016 in "Jothi Talkies West Pallakuchi Street Sri Kaliyamman Kovil" situated at I.E.Jothi Talkies, West Pallakuchi Street, Ammapet, Salem-636 003, the petitioner made a representation dated 11.4.2016 to the respondent. As the same has not been considered so far, the present writ petition has been filed.

3. I have heard the learned counsel appearing for the petitioner and the learned Additional Government Pleader, who has taken notice on behalf of the respondent.

4. Learned Additional Government Pleader, on instructions, would submit that there is likelihood of law and order problem.

5. A mere apprehension cannot be a ground to reject the representation of the petitioner. There is absolutely no material before this Court to hold that there will be a law and order problem in the event of permission being granted. In such view of the matter, the writ petition is allowed and the petitioner is permitted to conduct cultural programme on 29.5.2016 in "Jothi Talkies West Pallakuchi Street Sri Kalamman Kovil" situated at I.E.Jothi Talkies, West Pallakuchi Street, Ammapet, Salem-636 003, however, with the following conditions:-

(a) The cultural programme in connection with temple Festival in "Jothi Talkies West Pallakuchi Street Sri Kalamman Kovil" situated at I.E.Jothi Talkies, West Pallakuchi Street, Ammapet, Salem-636 003, to be held on 29.5.2016 between 06.00 p.m. and 10.30 p.m.

(b) There should not be any kind of obscene dance or vulgar dialogue during the performance, by anyone of the participants.

(c) Double meaning songs should not be played so as to spoil the minds of students and youths.

(d) No dance or songs, touching upon any political party or religion or community or caste be played.

(e) No flex boards in support of any political party or communal leader be erected.

(f) The function should not affect either religious or communal harmony and shall be conducted without any discrimination based on caste.

(g) If there is any violation of any one of the conditions imposed, the concerned police officer is at liberty to take necessary action, as per law and stop such performance; and

(h) Similarly, the police is entitled to stop the dance programme, if it exceeds beyond the permitted time.

Further, the respondent is directed to issue necessary permission, incorporating the above conditions. No costs.

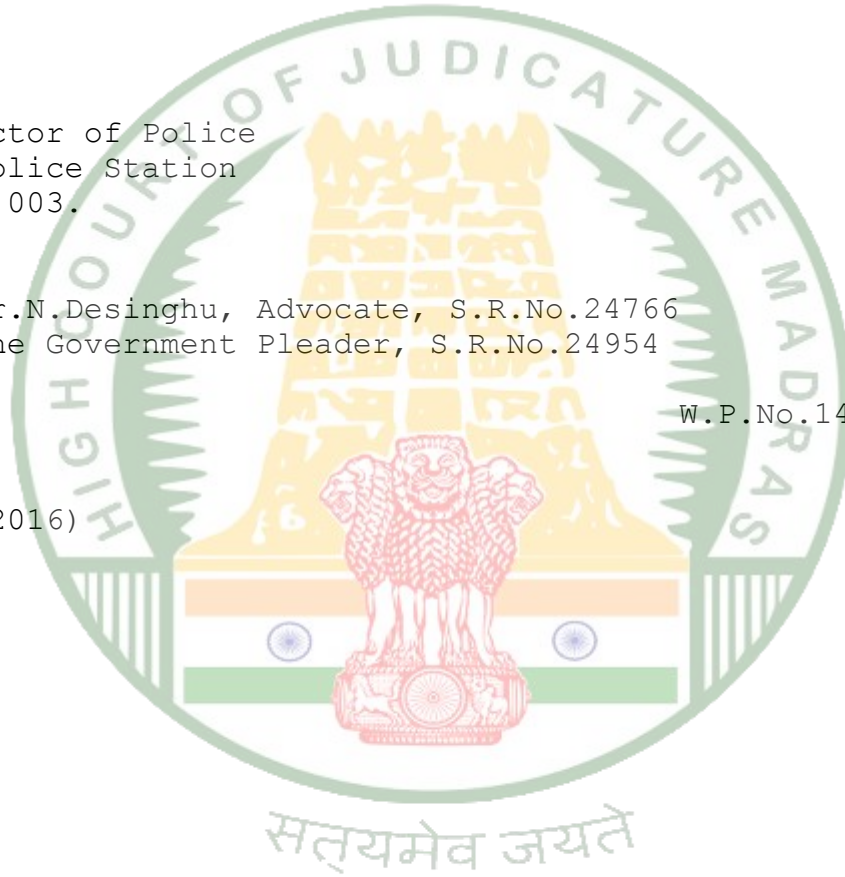
