O R D E R

Heard the learned counsel appearing for the petitioner and Mr.Mohamed Riyaz, learned Government Advocate (crl. Side) appearing for the respondent.

2.The petitioner herein has filed CrI.O.P.No.1911 of 2016 under Section 482 Cr.P.C. seeking a direction to the respondent police to register a case on the basis of the

complaint lodged by him dated 15.12.2015. This Court, by order dated 08.02.2016, directed the third respondent therein to expedite the enquiry and follow the dictum laid down in ***Lalitha Kumari v. Government of U.P. and others [2013 (4) Crimes 243 (SC)]*** and register a case, if any cognizable offence is made out.

3. According to the petitioner, the respondent/contemnor, who is the third respondent therein, has neither conducted any enquiry nor registered a case and that he has willfully disobeyed the order passed by this Court. Hence, the petitioner, has filed the present contempt petition.

4. Today, the respondent/contemnor is present and filed counter affidavit, stating that in obedience of the order passed by this Court dated 08.02.2016, enquiry has been conducted and closed as civil in nature and the closure report has been furnished to the petitioner today. He also tendered his unconditional apology for the delay in implementing the order of this Court dated 08.02.2016

5. Recording the above submission, this contempt petition is closed.
