4 The learned Additional Advocate General submitted that as against the order passed in the writ petition, a writ appeal has been preferred in WA.No.1226/2016 and the matter is likely to be listed tomorrow [29.09.2016] before the Division Bench of this Court. The learned Additional Advocate General, on instructions from the officer, who is present in Court, representing the Selection Committee,

submitted that the petitioner would be granted admission to the MBBS Course, subject to the outcome of the writ appeal, which has been filed by the respondents. The said submission is placed on record.

5 Recording the same, the contempt petition is closed and the respondent is directed to issue the Admission Letter to the petitioner by today.
