ORDER

The petitioner's appeal for promotion to the post of Deputy Commandant on par with his junior Mr.Durairaj was rejected by the order dated 12.1.2016 passed by the Additional Director

The writ petition is disposed of accordingly. Consequently, W.M.P.No.13623 of 2016 is closed. No costs.
