Petition filed under Article 226 of the Constitution of India praying for the issue of a Writ of Certiorarified Mandamus, to call for the Tamil Nadu Medical Services Corporation's recruitment advert for the post of 12 Assistant Engineer (Bio-Medical) published in their website; and G.O.(2D). No.24, dated 16.02.2012, referring to the recruitment of 49 Assistant Engineers (Bio-Medical) recruited by the Tamil Nadu Health Systems Project and later absorbed by Tamil Nadu Medical Services Corporation as it is illegal, null and void and directly violative of due process of law; and to subsequently to direct the 3rd respondent to issue fresh notification in relation to the recruitment of 61 Assistant Engineer (Bio-Medical) following appropriate procedure.
