petitioner's property to four persons illegally.

4. The complaint does not even disclose the date of sale.
Hence, no positive direction can be issued to the respondent-Police
to register an FIR, on the complaint dated 15.04.2014.

Hence, this Criminal Original Petition is closed with liberty to the petitioner to work out his remedy in the manner known to law.

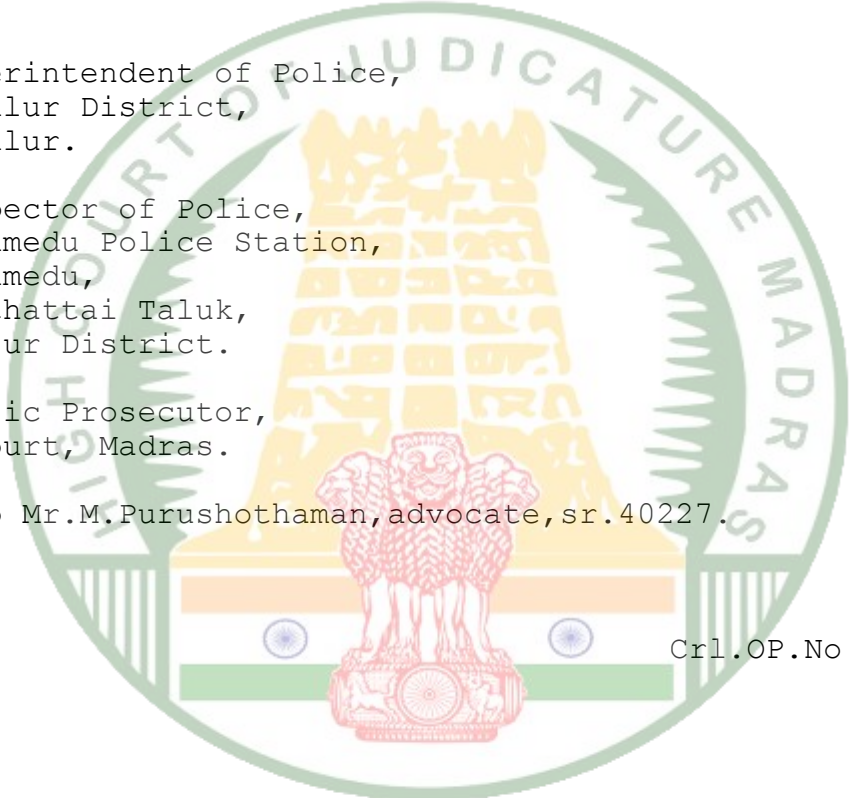
