PETITION under Article 226 of The Constitution of India praying for the issuance of a Writ of Certiorarified Mandamus to call for the records on the files of the first respondent in its proceeding in PU/AW-2/SVMCH&RC/2016-17/51 dated 4.4.2016 refusing to grant consent of affiliation for the Post Graduate Courses of new PG course for MD (Tuberculosis & Respiratory Diseases) and increase in intake for MD (Psychiatry), MS (ENT), MD (General Surgery), MD (DVL), MS (OBG), MS (Orthopaedics), MD (General Medicine), MD (Radio Diagnostics) and MD (Ophthalmology) for the academic year 2017-18, quash the same as arbitrary, unreasonable and violative of the principles of natural justice, hence violative of Article 14 of The Constitution of India and direct the first respondent to issue the consent of affiliation for the Post Graduate Courses of new PG course for MD (Tuberculosis & Respiratory Diseases) and increase in intake for MD (Psychiatry), MS (ENT), MD (General Surgery), MD (DVL), MS (OBG), MS (Orthopaedics), MD (General Medicine), MD (Radio Diagnostics) and MD (Ophthalmology) for the academic year 2017-18
