Ka. NO.156/2013 dated 6.1.2014 published in Dinathanthi newspaper on 14.1.2014 in so far relates to Shop NOS.1 and 2 and vacant site for running hotel and right to collect amount for pay and use toilet situated in Bus Stand Muthur Tiruppur District and quash the same and consequently direct the respondent to extend the lease period for another three years as per G.O.Ms.NO.92 Municipal Administration Department dated 3.7.2007.
