3. It is seen that this petitioner has sent a complaint dated 20.04.2016 by post to the 5th respondent Police, alleging that one Loganathan and sons had assaulted him on 20.04.2016, when electricians came to the place of the petitioner to give electricity connection.

Learned Additional Public Prosecutor submitted that though the complaint was sent by post, petition enquiry was conducted and since there was no material to show that the petitioner was assaulted, the same was closed. A copy of the Closure Report is furnished to the learned counsel for the petitioner, across the bar.

Recording the same, this petition is closed, with liberty to the petitioner to workout her remedies in the manner known to law.
