This being the girls school and especially in view of the averment in paragraph 9 of the affidavit of the Headmistress, it is advisable that the proceedings before the first respondent are concluded expeditiously with follow up action.

2. We call upon the first respondent/Commissioner, Madurantakam Municipality to take a final view in the matter after notice to all concerned within a maximum period of one month from today.

3. The writ petition, accordingly, stands disposed of. No costs.
