Prayer: Writ Petition filed under Article 226 of the Constitution of India, seeking for a writ of mandamus, to direct the respondent authority to give permission to conduct the cultural program in Mangalampatti Thinnanuru Nadar Arulmighu Sri Mariamman Koil Abhishekavizha, Senthamangalam Taluk, Namakkal District on 08.06.2016 by considering the petitioner's representation dated 27.05.2016.

O R D E R

By consent, the writ petition is taken up for final disposal.

2 The petitioner claims to be the Secretary of the Festival Organizing Committee of Arulmighu Sri Mariamman Koil, situate at Mangalampatti village, Senthamangalam Taluk, Namakkal District. He submitted a representation/application dated 27.05.2016 to the respondent, seeking permission to conduct a cultural program on 08.06.2016, in connection with the consecration festival of the temple, which includes song and dance programme and since, he has not been favoured with any kind of response, came forward to file this writ petition.

3 Learned counsel appearing for the petitioner, on instructions, would submit that in the event of permission being granted to conduct the song and dance programme, there will not be any law, order or communal problem and no vulgarity or obscenity will be there and hence, prays for appropriate orders.

4 This Court heard the submissions of Mr.S.Navaneethan, learned Additional Government Pleader, who accepts notice for the respondents.

5 This Court, taking into consideration the limited scope of the prayer sought for by the petitioner and without going into the merits of the application/representation, directs the respondent to consider the application/representation dated 27.05.2016, in accordance with law and pass orders on or before 06.06.2016 and communicate the decision taken, to the petitioner forthwith.

6 The writ petition is disposed of, accordingly. No costs.
