2 The petitioner claims to be the Secretary of the Festival Organizing Committee of Shri Iyyanar Koil, situate at Ponkudikadu village, Chenthurai Taluk, Ariyalur District. He submitted a representation/application dated 30.05.2016 to the respondent, seeking permission to conduct a cultural program on 10.06.2016, in connection with the consecration of the temple, which includes song and dance programme and since, he has not been favoured with any kind of response, came forward to file this writ petition.

3 Learned counsel appearing for the petitioner, on instructions, would submit that in the event of permission being granted to conduct the song and dance programme, there will not be any law, order or communal problem and no vulgarity or obscenity will be there and hence, prays for appropriate orders.
