COMMON ORDER

3. The writ petitions, accordingly, stand disposed of. No costs. Consequently, M.P.No.1 of 2009 in W.P.No.7770 of 2009 is closed.

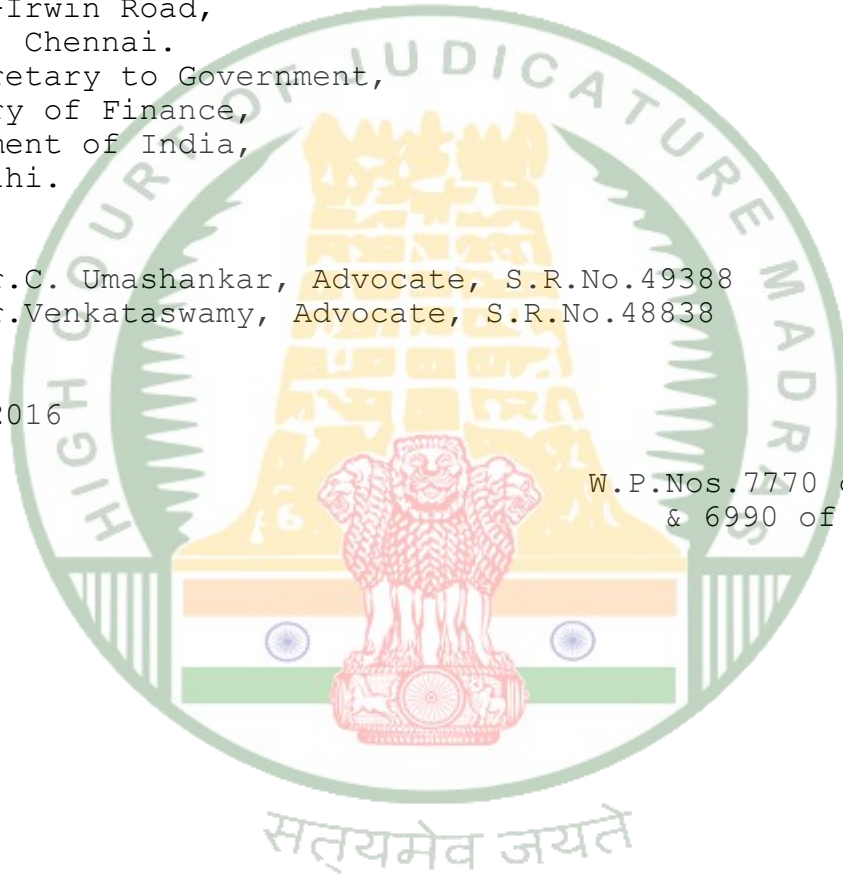
