In the circumstances stated, the learned Subordinate Judge, Tambaram, is directed to dispose of the case as expeditiously as possible in keeping with the requirement of Section 13(b) of the Hindu Marriage Act.

The Transfer Civil Miscellaneous Petition is disposed of with the above direction. No costs. Consequently, connected miscellaneous petition is closed.

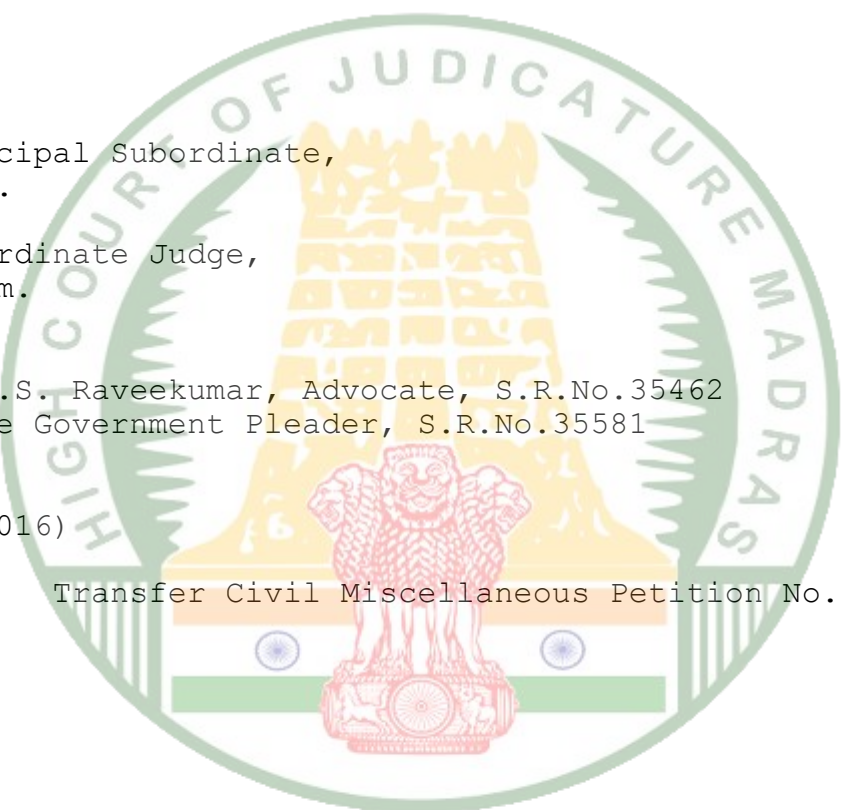
