The Presiding Officer, Sub Court, Tiruppur is directed to dispose of the case in H.M.O.P.No.1097 of 2008 within a period of six months from the date of receipt of a copy of this order.

5.Accordingly, this Transfer Civil Miscellaneous Petition is ordered. No costs. Consequently, connected Miscellaneous Petition is closed.
