Writ Petition filed under Article 226 of the Constitution of India to issue a Writ of Declaration to declare that by applying the policy in G.O.Ms.No.124 dated 15.05.2008 passed in connected with the Public Works Department to the Corporation of Chennai, the petitioner is deemed to have completed more than 10 years in the Corporation of Chennai in the posts of Technical Assistant and Junior Engineer and hence eligible for promotion to the post of Assistant Executive Engineer as per the Chennai Corporation Engineering Service Rules, 1969 dealing with the post of Assistant Executive Engineers and consequently to direct the respondents to consider the petitioner for the 50 posts of Assistant Executive Engineers and promote him as Assistant Executive Engineers forthwith.

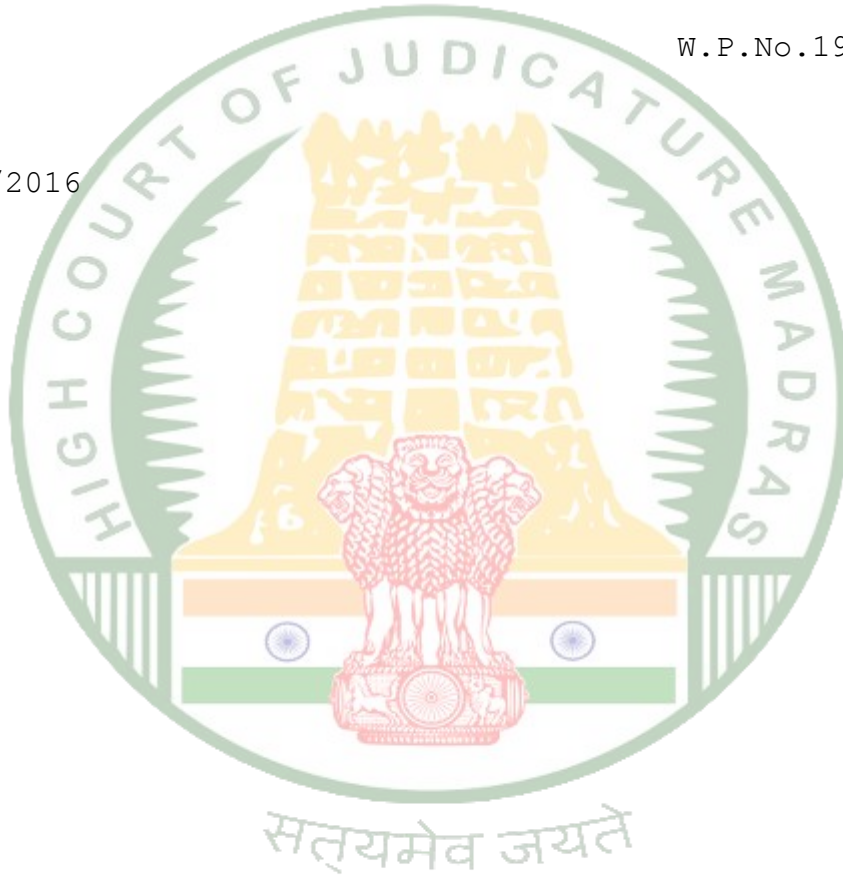
