Prayer in WP.Nos.18840, 18842 & 18843/2014:- Writ petitions filed under Article 226 of the Constitution of India praying for the issuance of a Writ of certiorari calling for the records of the 2nd respondent dated 09.09.2011, 21.12.2012 and 13.08.2013 respectively in F.No.OCA/MDS/3042/2011 ; F.No.OCA/MDS/3044/2012 and F.No.OCA/MDS/3044/2012 and quash the same.

Prayer in WP.Nos.18841 & 18844/2014:- Writ petitions filed under Article 226 of the Constitution of India praying for the issuance of a Writ of certiorarified mandamus calling for the records of the 1st respondent dated 12.05.2010 in G.O.No.SR.1/822-5/2009 issued u/s.3[1] of COFEPOSA and quash the same and consequently direct the 2nd respondent to drop all proceedings initiated against the petitioner u/s.6[1] of SAFEMA.
