WP No.5625 to 5634 of 2013: Petition filed under Article 226 of the constitution of India, to issue Writ of Certiorari, calling for the records pertaining to the impugned Communication sent by the 3rd respondent to the 2nd respondent bearing Roc.No. 5140/ 2012/MH-5 dated 11.2.2013.

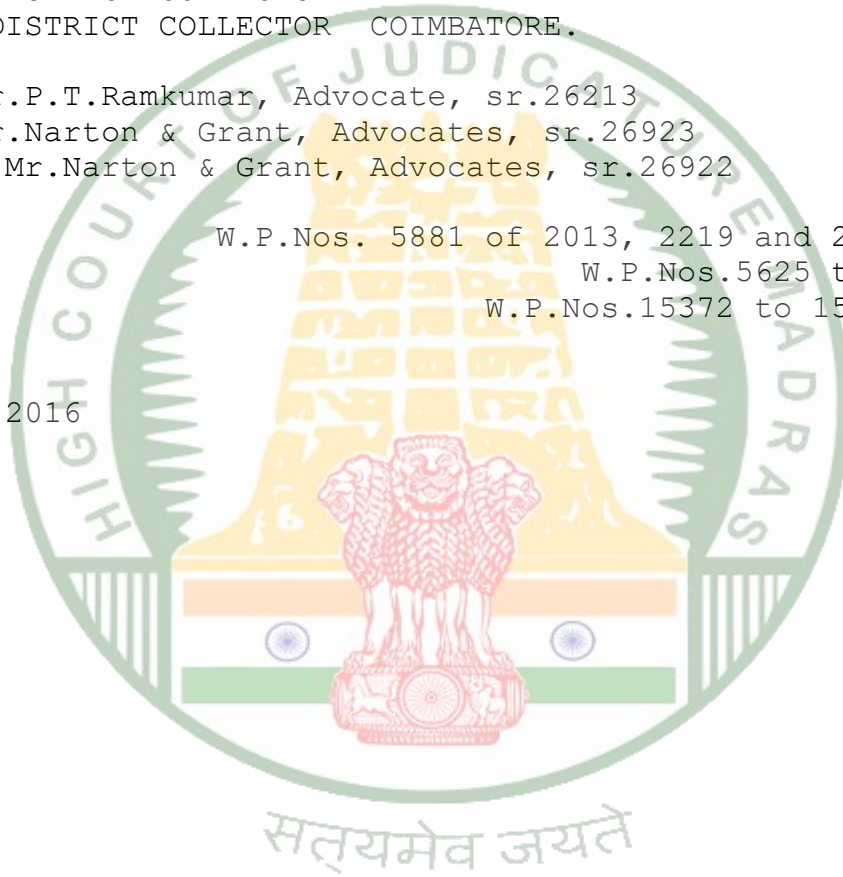
