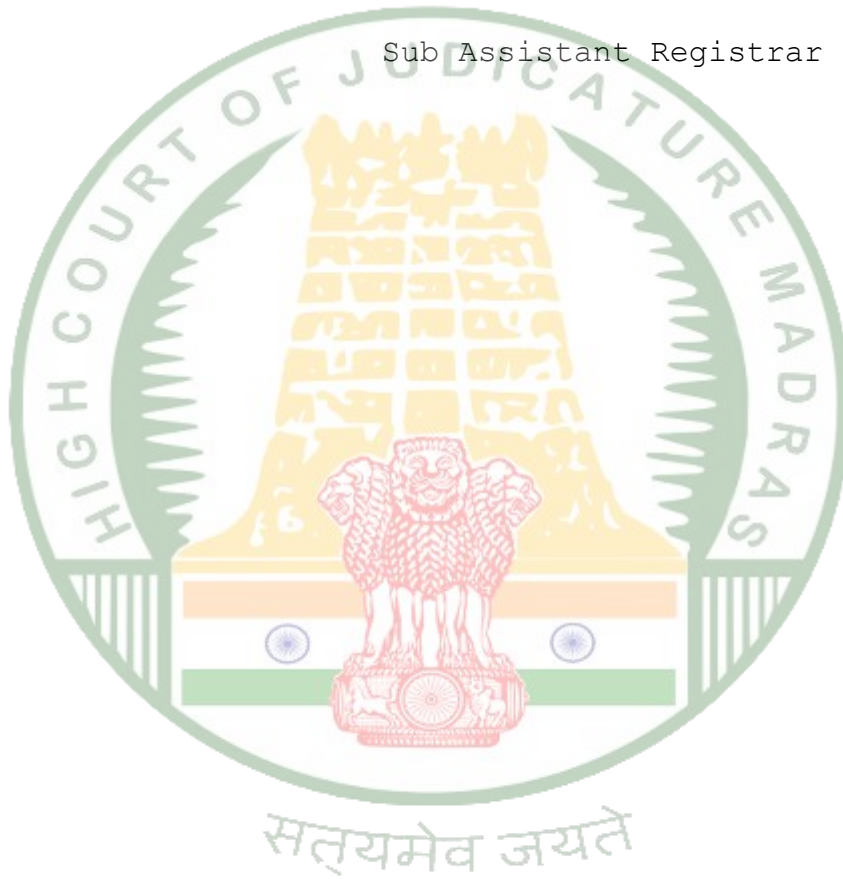
2. The writ petitions, accordingly, stand disposed of. No costs. Consequently, M.P.Nos.1 of 2014 (four petitions) are closed.

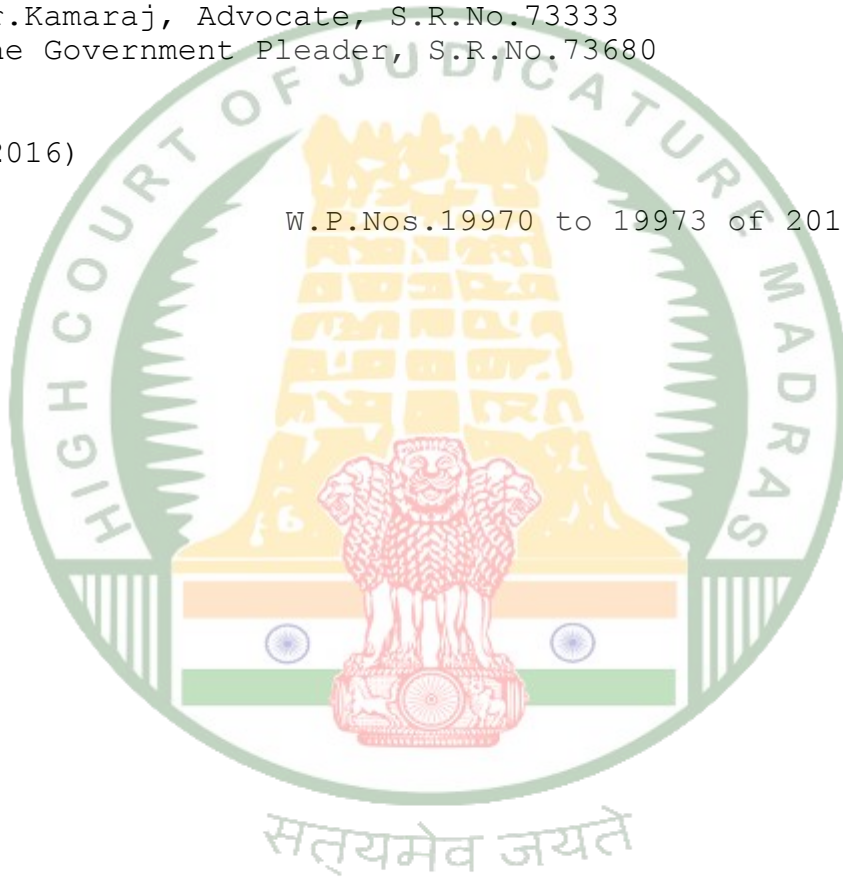
