Considering the limited prayer now sought for by the learned counsel for the petitioner, without going into the merits of the case, the 1st respondent is directed to consider and dispose of the representation of the petitioner dated 7.5.2015, on merits and in accordance with law, within a period of one month from the date of receipt of a copy of this order.

5. With the above directions, this Writ Petition is disposed of. No costs.
