ORDER

(Order of the Court was made by the Hon'ble Chief Justice)

The learned Special Government Pleader has produced before us the Notification regarding Reservation of Seats of Wards of Panchayat Union Councils and Territorial Wards of District Panchayats.

2. The learned counsel for the petitioner has produced before us a chart giving the nine constituencies, two of which are reserved for SC/ST. Thus, the only question is whether three of these nine are reserved for women, with one for SC/ST women. On verification, it is found as under:
