Since the dates, relating to the holding of the examinations, pertaining to BAMS course, in the Pondicherry University, had already lapsed, the relief prayed for by the petitioners cannot be granted, by this Court, at this stage. Accordingly, the writ petition stands dismissed, as infructuous. No costs. Consequently, connected miscellaneous petition is closed.
