3.Having regard to the submissions made by the learned counsel on either side, taking into consideration the limited prayer sought for in these Writ Petitions, without expressing any opinion with regard to the merits of the case, this Court directed the respondent to receive the applications of the petitioners dated 20.05.2016 in Form CCPA and the prescribed fee for the grant of Auto Rickshaw Permit and to consider the same, on merits and in accordance with law, within a period of six weeks from the date of receipt of a copy of this order.

4.With this observation, the Writ Petitions are disposed of. No costs.
