2.The instant writ petitions are filed, seeking a direction to respondents 2 and 3 not to initiate any coercive action till the disposal of the petitioners' appeals preferred before the District Collector and in the meantime, status quo be maintained.

3.We are informed that the appeals preferred by the petitioners were disposed of by the District Collector, Kancheepuram vide proceedings in Na.Ka.No.8441/2006/N1 dated 07 January 2016. Thus nothing survives for adjudication in these writ petitions.

4.The writ petitions have become infructuous and the same shall stand dismissed as having become infructuous. No costs. Consequently, connected miscellaneous petitions are closed.
