Prayer: Writ Petition filed under Article 226 of the Constitution of India, seeking for a writ of mandamus directing the 2<sup>nd</sup> and 3<sup>rd</sup> respondents to subdivide and demarcate the land in Survey Nos.381-2, 382-2, 377, 378/1, 367/1, 379/1A, 386/1B situated at A.Mettupalayam Village, Annur Taluk, Coimbatore District by install the patio stone as per the partition deed document No.4539/2014 dated 10.03.2014 and issue separate patta in favour of the petitioners based on the petitioner's application No.2015/0105/12/000353 dated 11.12.2015.

ORDER

By consent, the writ petition is taken up for final disposal.

2 The petitioners claim right, title and possession in respect of the following properties:-

by way of registered Partition Deeds bearing Document Nos.4539/2014 and 4540/2014 dated 10.03.2014, registered on the file of the Sub Registrar, Annur Taluk. It is stated by the petitioners that on 11.12.2015, an application was submitted by them to the 2<sup>nd</sup> respondent for measuring the said properties and also install boundary stones and to issue separate patta. It was also followed by a reminder dated 25.05.2016 and since no orders have been passed, they came forward to file the present writ petition.

3 Heard the learned counsel for the petitioner and Mr.S.Navaneethan, learned Additional Government Pleader who accepts notice on behalf of the respondents.

4 Though the petitioners have prayed for a larger relief, this Court, in the light of the facts and circumstances and without going into the merits of the claim projected by the petitioners, directs the respondents 2 and 3 to consider and dispose of the petitioners' representation dated 11.12.2015 and the reminder dated 25.05.2016 on merits and in accordance with law, after putting on notice the person/s concerned and pass orders within a period of eight weeks from the date of receipt of a copy of this order and communicate the decision taken, to the petitioners as well as to the person[s] concerned.

5 The writ petition is disposed of with the above direction. No costs.

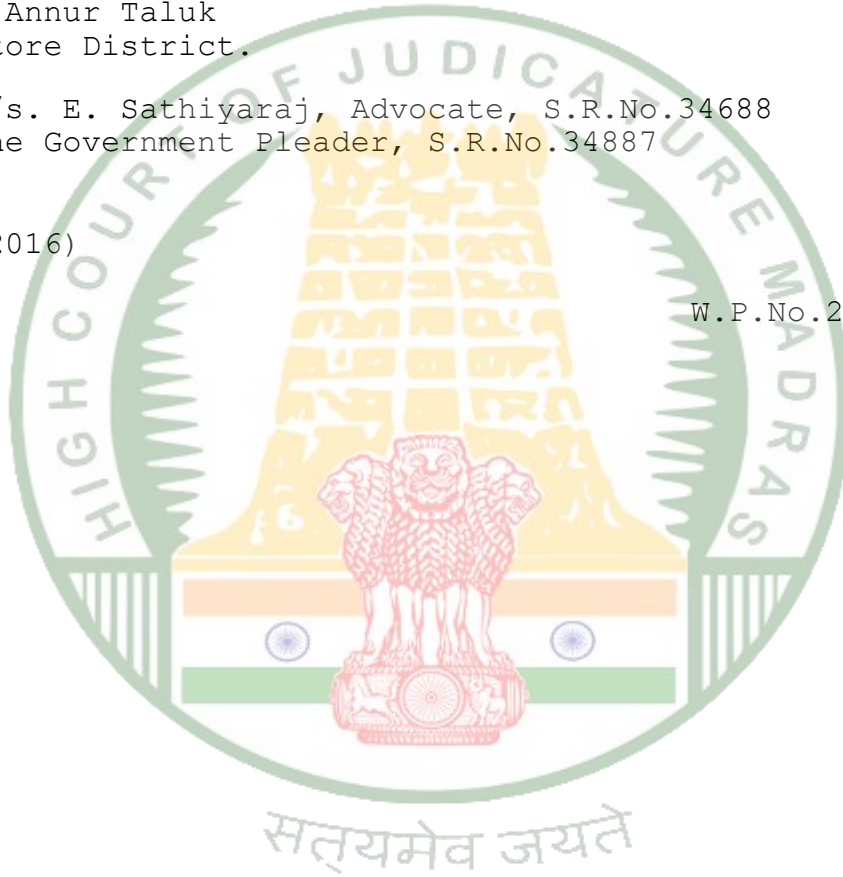
