2. According to the petitioner, he joined the service of the respondent Corporation on 14.06.2010 as Junior Assistant. While so, the petitioner was placed under suspension by an order of the respondent dated 04.09.2015.

3. The petitioner would further state that he is suffering with great mental agony and hard ship due to the suspension. Therefore, he made a representation to the respondent on 16.12.2015 to revoke the order of suspension. Since it was not considered, the present writ petition has been filed.

4. Heard Mr.Balan Haridas, learned counsel appearing for the petitioner and Mrs.M.E.Rani Selvam, learned Additional Government Pleader, who accepts notice on behalf of the respondent.

This Court, in the light of the above facts and circumstances, permits the petitioner to submit one more representation to the respondent by enclosing a copy of this order as well as copy of the relevant records, within a period of two weeks from the date of receipt of a copy of this order. The respondent, on receipt of the same, is directed to consider the said representation on merits and in accordance with law and pass appropriate orders within a period of six weeks therefrom and communicate the decision taken, to the petitioner.

The Writ Petition is disposed of accordingly. No costs. Consequently, connected miscellaneous petition is closed.
