It is the petitioners' own case that notices in accordance with law have been issued to them under Sections 220 and 222 of the Chennai City Municipal Corporation Act, 1919, which naturally envisage the procedures set out therein to be followed.

2. There is, thus, no reason for us to interfere under Article 226 of the Constitution of India at this stage.

3. Writ petitions are dismissed. No costs. Consequently, W.M.P.Nos.18797 to 18800 of 2016 stand dismissed.
